Please see below list of all current awarded contracts based on GLA/TfL usage. Please note that this usage data does not include contracts which are yet to be confirmed or procurement processes that are currently out to tender.

Since its launch in April 2018, and in addition to the GLA/ TfL usage indicated in these figures, the Mayor's ADUP framework has also been used to procure architectural design services by a variety of public sector organisations for 37 different projects across London, ranging in scale from public realm interventions to large scale estate regeneration and town centre masterplans.
